

Chance Drawing Rules

The Prize: One grand prize "Winner" will be chosen at random from the ticket holders. The winner will receive a 2019 Land Rover Discovery Sport SE (SALCP2FX1KH783514) at an MSRP of \$39,610 (the "Vehicle") The prize cannot be exchanged for cash, but, in substitution for the Vehicle, Wilde Land Rover ("Dealership") will provide a credit of equal value towards the purchase of another vehicle by the Winner from the Dealership. The Winner will be responsible for paying all fees, taxes and charges (including, but not limited to tag, title, registration, and license fees) in connection with the Vehicle. In addition, insurance, maintenance and all other costs of Vehicle ownership are the sole responsibility of the Winner. The Van Wezel Foundation, Inc., a Florida nonprofit corporation (the "Foundation"), assumes no responsibility whatsoever for the Winner's tax obligations or any fees or charges incurred in connection with the Vehicle, and the Foundation will not have any responsibility once the Vehicle has been conveyed or delivered to the Winner.

Eligibility: Winner must be a citizen or permanent resident of the United States. Only licensed drivers (license cannot be suspended) that are 18 years of age or older at the time of ticket issuance are eligible to participate and enter the drawing. The Foundation reserves the right in its sole and absolute discretion to disqualify any ticket holder for violation of these Official Rules or any applicable laws or who makes any misrepresentations relative to this drawing. The Winner may be required to sign and deliver to the Foundation an affidavit of eligibility, a release of liability, and appropriate tax forms in order to receive the Vehicle. The Foundation employees and their immediate family members (spouse, parent, children, and grandchildren) are not allowed to participate and are ineligible to win.

Entry and Tickets: Participation in this drawing by chance will be through ticket issuance. A maximum of 1,000 qualified tickets will be issued. Ticket requests will be accepted (in person) until 6:30 pm on, February 16, 2019. All 1,000 tickets may be issued prior to that date and time. No purchase or donation is necessary to obtain a ticket and enter the drawing. A \$100 donation to the Foundation is the suggested minimum donation for a ticket for this drawing by chance. Ticket requests received in writing must be post-marked no later than **Friday, February 8, 2019**, and any written ticket requests received after that date will not be accepted. Tickets are not transferrable and no replacements will be issued.

Selection of Winner: The Winner will be selected at random at the Van Wezel Foundation Gala held on Saturday, February 16, 2019 at the Van Wezel Performing Arts Hall, however, this date and all other dates stated in these Official Rules may be extended in the Foundation's sole and absolute discretion. The Winner does not need to be present to win. The odds of winning depend upon the number of tickets issued, and making a donation will not affect the likelihood of winning. The Winner will be notified by certified mail, according to the contact information provided to the Foundation at the time of entry. If the Winner cannot be contacted, fails to respond within 14 calendar days, fails to otherwise qualify for the prize or declines the prize, the Winner will forfeit any and all rights to the Vehicle, and the Foundation will select an alternative Winner. The Winner must provide a valid driver's license and evidence of insurance prior to delivery of the Vehicle.

Release and Indemnification: By participating in this drawing by chance, each participant releases the Foundation and all of its directors, officers, employees, agents, volunteers, committee members, representatives, the Dealership and Dealership affiliates (collectively, the "Foundation Affiliated Parties") from any and all liability for injuries, losses, costs, taxes, fees or damages of any kind arising out of, resulting from, or caused by participation in the drawing by chance, the Vehicle, or for any error or mistake in handling this drawing by chance, resulting from acceptance, possession, use or misuse of the Vehicle. The Winner agrees to indemnify and hold harmless the Foundation and the Foundation Affiliated Parties from any and all losses, damages, costs expenses, rights, claims, and actions of any kind arising in connection or as a result of the Winner's acceptance or use of the Vehicle. The Foundation is not responsible for any incorrect or inaccurate information, and the Foundation assumes no responsibility for any error, omission, deletion or defect in any ticket or in the operation of this drawing by chance. This offer is void where prohibited by law and all federal, state, and local laws and regulations apply. The Foundation will resolve all disputes in its sole and absolute discretion.

Taxes and Deductibility: Payment of all applicable federal, State and Local taxes, are the responsibility of, and must be paid by the winner(s). Winner(s) will be issued Internal Revenue tax form(s) 1099 stating the value of the prize(s). This includes, without limitation, use on any marketing, advertising, social media or any other promotional materials with full exclusive rights.
